The Method of Personal Data Collection and its Legal Reason

Your personal data is collected on the basis of legal reasons for the legitimate interest of our Company through cookies in the electronic environment when you visit our website or use our application. Marketing and advertising activities through targeting and profiling are carried out only if you give your explicit consent. Your collected personal data may also be processed for the purposes specified in this Cookie Disclosure Text within the scope of the conditions and purposes of personal data processing specified in Articles 5 and 6 of the Law.

To Whom and for What Purpose Such Personal Data may be Transferred

We, EIP, may share your personal data under this Cookie Disclosure Text with our suppliers, legally competent public institutions and legally authorized private persons as limited to the realization of the below mentioned purposes and in accordance with the relevant legislation.

Which Cookies Are Used For Which Purposes?

We, EIP, use cookies for various purposes on our site and application and we process your personal data through these cookies. These purposes are mainly:

- To analyze the Site and the application, to increase the performance of the Site and the application. For example, the integration of different servers on which the Site operates, determining the number of visitors to the Site and making performance adjustments accordingly, or facilitating visitors to find what they are looking for.
- To increase the functionality of the site and the application and to provide a user friendly environment.

For example, sharing on third-party social media channels through the Site, remembering the username or search queries the next time the visitor visits the Site.

To carry out personalization, targeting and advertising activities. For example, displaying
advertisements related to visitors' interests according to the pages and products viewed by the
visitors.

Cookies Used in Our Site and Application

Below you can find the different types of cookies we use on our site and application. We use both firstparty cookies (placed by the site you visit) and third-party cookies (placed by the servers other than the site you visit) on our site and application.

Mandatory Cookies

The use of certain cookies is mandatory for our website and application to function properly. For example, authentication cookies, which are activated when you log on to our site, ensure that your active session stays on even when you navigate through the pages on our site.

Functionality and Preference Cookies

These cookies enable the personalization of the services offered on our site by remembering your preferences and choices on the site and application. For example, it allows us to remember your language preference on our site or the font size you chose when reading a text.

Social Media Cookies

What are your Rights As a Data Owner?

In accordance with Article 11 of the Law on PPD, the data owners have the following rights:

- To know if their personal data has been processed or not,
- If their personal data has been processed, to request information in this regard,
- To know the purpose of processing of their personal data and whether or not such has been used for its intended purpose,
- To know the identities of the domestic or foreign third parties to which their data has been transferred,
- To request the correction of their personal data in case of incomplete or inaccurate data, to request that this correction be communicated to third persons to which such personal data has been transferred in the first place,
- Although their personal data has been processed in accordance with the provisions of the Law on the PPD and other related laws, to request the deletion or destruction of their personal data in case the reasons that require such processing cease to exist, and to request that this action be communicated to third persons to which such personal data has been transferred,
- To object to any negative result arising against such person out of analyzing such processed data exclusively through automated systems,
- ¹ To request compensation for any loss suffered by you in case your personal data is processed in violation of the relevant legislation.

You can submit your requests regarding your rights listed above to our Company by filling out the Data Owner Application Form available at here. Depending on the nature of your request, your submission shall be concluded free of charge as soon as possible and within thirty days in any case; however, if this operation requires any cost, you may be charged a fee according to the tariff to be determined by the Personal Data Protection Board.
